Coaches will be subject to criminal background checks and must provide full disclosure of any incidents relating to convictions involving the use of force in any time period, any crime involving a minor in any time period, and multiple alcohol or drug convictions in the past 5 years. Coaches must be committed to and must have demonstrated the ability to live in harmony with other members of the community, within social & legally acceptable standards for leadership and teaching of our children. Candidates with backgrounds that demonstrate a blatant disregard for others, the law, and a pattern of self destructive behavior are not fit for coaching youth sports in any organization, including the Westminster Wildcats.

Disqualifying convictions are:

- 1) Any crime involving the use of force against another person at any time in history
- 2) Any crime involving a minor at any time in history
- 3) Any multiple (more than 1) convictions in the past 5 years for drugs and/or alcohol
- 4) Any other multiple convictions or patterns of behavior resulting in multiple charges in the past 10 years, which demonstrate blatant disregard for others, the law and a pattern of self-destructive behavior
